## **Notes from the President....**

Again, what a wonderful year NAMI-FL has experienced in 2008...our second full year as an incorporated not-for-profit. We elected 4 new Board Members – Linda Duttweiler, Deb Grantham, Rebecca Schwed, and Sherry Scott. We also elected Officers for this new year – President -- Carol Booth, Vice President – Ann Carter, Recording Secretary – Sherry Scott, Corresponding Secretary – Rebecca Schwed, and Treasurer – Joanne Denison and set several important Committees to help carry out our very important work. We held four official Board Meetings – March, May, September, and November. In the spring of 2008 we sponsored our 7<sup>th</sup> F2F Education Class and our 2<sup>nd</sup> Annual Rally to Raise Awareness of Mental Illness and Support Mental Health – a great Community Event. Tom O’Clair, spearhead for Timothy’s law and now working as an Office of Mental Health Recipient Services Assistant, came to speak -- his words were extremely powerful, along with those from families, teachers, mental health providers, and recipients.

Later in August NAMI-FL held its yearly picnic at Stewart Park – on one of the windiest evenings of the summer! Those of us in attendance challenged the elements and had a wonderful time. “Trish and Friends” entertained us with enthusiasm!! In October, NAMI-FL sponsored a very successful Wellness Event—Mind and Body: Integrated Physical and Mental Health. John Allen, Director of Recipient Services at the OMH gave the Key Note address and then we convened a local panel to address some issues from their perspective. – experts on diabetes, nutrition, exercise, holistic approaches, and our local metabolic clinic. We also did a great deal of Outreach in 2008 – particularly with NYSEG, the hospital, and Ithaca College. Andrea Staffeld and Susan Larkin spoke in a Psychology Seminar and Carol Booth taught an entire class in the “Culture of Disability.” Honoraria in both cases were donated to NAMI-FL. Our Support – both individual and group – was praised by family members, close friends, and providers, and recipients in the Ithaca area.

Now that we have entered 2009 and rather difficult economic times, we must take time to prioritize our most important needs – as well as providing Support, Education, and Advocacy along the way. We continue to gain the reputation of providing quality services to family members and recipients and being a necessary partner to other service providers. This year we did

not receive the typically large donation from our Cornell Fraternity Fund Raiser that we have been the appreciative beneficiary of for many years, so one of our priorities in 2009 is to find other reliable sources of income. I was able to find money (Transitional Living Services in Syracuse) to purchase a new computer monitor and some new software – so our second priority will be to upgrade our use of this new technology. We will transfer our finances to Quicken and update all of our mailing lists – Members, Friends, and entire Mailing list. Jean, Joanne, David Zimet and others will all learn how to use this new software effectively. We will certainly continue to fight STIGMA at all levels – through our Family to Family Education Course, through our regular outreach attempts in the Community, and through our connections to other advocacy groups. This is a BIG JOB and a continuous one. I also continue to teach school children throughout the TST BOCES District – Trumansburg and Dryden have been long-time partners in this effort.

My work as Secretary of NAMI-NYS for the last three years has been challenging, but at the same time – satisfying. I am able to network with other individuals from all over the state and keep up with the most important issues facing those heroic individuals struggling with these devastating illnesses and their courageous families and close friends. I have been involved with Children and Adolescents, Wellness, and Educational Programs. One thing I know for sure – the Treatment and Services that we have here in the Ithaca Community and Tompkins County are of very high quality. We do have housing available and case management for those who need it – we also have a very short waiting list for County Mental Health Services – this is not so in many other parts of New York State. We have much work ahead of us, but we have excellent partners with whom to collaborate to help our loved ones have the best quality of life that is possible in such difficult circumstances.

## 1) INTRODUCTION

NAMI-FL, Inc. is an organization founded by families who have loved ones struggling with a major mental illness – Major Depression, Bipolar Disorder or Manic-Depression, Schizophrenia, Anxiety Disorders, Borderline Personality Disorder, PTSD, and other co-occurring Addictive Illnesses. Our Affiliate was founded in 1987 by Jean and Verle Walters and has been operating out of her residence at 104 East Lewis Street, Ithaca, NY since that time.

### **Our organization serves to:**

- Provide Support for families, relatives, and close friends of those individuals struggling with major mental illness
- Educate families, recipients, and the community about serious mental illnesses
- Advocate for the families as well as family members coping with serious mental illness

### **Our Goals are:**

- Provide a SELF-HELP GROUP for parents, spouses, siblings, children, and friends of individuals with mental illnesses
- Educate ourselves and the public about the truth concerning the major mental illnesses and seek to change Stereotypes and overcome STIGMA and DISCRIMINATION

- Advocate for the best possible delivery of TREATMENT and SERVICES for individuals with serious mental illness
- Support RESEARCH for improved medications and treatments for individuals with mental illnesses today and to find the cure for mental illnesses in the future.

## 2) SUMMARY OF ACCOMPLISHMENTS IN 2008:

### **Support:**

- Ran a monthly Support Group on Tuesday evenings (Jean's house) and for about 6 months on Wednesday evenings ( Wegman's) with a total cumulative attendance of about 111 individual visits
- Individually met with or spoke with on the telephone approximately 52 individuals or families, meeting in the Office and out in the Community.
- Received approximately 358 telephone calls – including those received by Carol Booth at home
- Assisted others in starting a Support Group – Active Minds at IC and friends from Cortland County

### **Education:**

- Engaged in Outreach at the Tompkins County Public Library, NYSEG, our Rally in May, two Classes at Ithaca College, and our Wellness Event in October.
- Organized our 2<sup>nd</sup> Annual Rally to Raise Awareness about Mental Illness and Support for Mental Health. Tom O'Clair spoke to a good-sized group down at DeWitt Park – along with an array of other interesting, informative, and inspirational speakers.
- Sponsored an important Community Event downtown at the Library – Mind and Body: Integrated Physical and Mental Health. John Allen gave an excellent Key Note address on the importance of treating the

whole person, not just the mental illness. We invited a wonderful local panel to emphasize the need for physical/mental health treatment.

- Sponsored our 7<sup>th</sup> Family to Family Education Course, taught by Jean Poland and Janet Lynch and assisted by Joanne Denison. 16 people graduated from this course.
- Presented Breaking the Silence to approximately 600 school students in the TST BOCES District
- Hosted Kevin Nickerson from Challenge to speak to members and friends about all types of Benefits – including Ticket to Work and Medicaid By-In.
- Donated more Family Packets to Cayuga Medical Center, Behavioral Health Unit
- Published two Newsletters – January/February and July/August

#### **Advocacy:**

- Participated in Tompkins County Mental Health Services Board and Chaired MR/DD Subcommittee
- Participated in NYS- NAMI Board – advocated for Child and Adolescent issues and Integrated Health issues
- Advised family members in advocating for themselves and loved ones in the mental health and criminal justice systems

#### **More Details:**

- Breaking the Silence Lessons for school-age children

Breaking the Silence is in its 9<sup>th</sup> year – bringing lessons about mental illnesses to students and staff in the TST BOCES District. Carol Booth consults with teachers and administrators and presents to students in 5<sup>th</sup>, middle school, and high school classrooms.

- **7<sup>th</sup> Family to Family Education Course**

Seven Classes ago, Jean Walters and Carol Booth taught the first F2F Education Class here in Tompkins County - we had over 20 participants. Since that time we have continued to offer this very important Course to family members and friends of individuals struggling with one of these major mental illnesses – Major Depression, Bipolar Disorder (Manic Depression), Schizophrenia, Anxiety Disorders, Borderline Personality Disorder, PTSD, and co-occurring Addictive Illnesses.

- **2<sup>nd</sup> Rally to Raise Awareness for mental Illness and Support Mental Health**

This past May, NAMI-FL sponsored its second Rally downtown at DeWitt Park. The Rally Committee asked Tom O'Clair, father of Timothy O'Clair, and Advocate for Timothy's Law, to come and speak in Ithaca. Along with Tom, we had an array of family members, recipients, our County Mental Health Commissioner, and service providers to educate and inspire. Many Community Agencies also participated with information about important services.

- **Mind and Body: Integrated Physical and Mental Health**

In October, NAMI-FL planned and carried out an excellent program on Wellness. John Allen from Recipient Affairs at OMH offered the Keynote Address and he was followed by a local panel of experts – on diabetes, nutrition, exercise, holistic treatments, and our own metabolic clinic. This topic of making sure that individuals with serious mental illnesses are also monitored for other serious, chronic illnesses such as high blood pressure, high blood sugar, high lipid count, obesity, etc. is extremely important and we helped bring this Awareness to the Community at large.

- **NAMI-NYS Educational Conference in November, 2008**

Jean Walters, Janet Lynch, and Carol Booth represented our local Affiliate at this Conference in Albany. We found the speakers to be informative and inspiring and the networking with old and new friends to be so enjoyable.

- **December Social**

We had a ‘record’ turn-out at our December social – almost **30** people. The food was wonderful and all who attended seemed to really enjoy the great music offered by David, Meyer, and Susan and the opportunity to see old friends and meet new ones.

### **3) MEMBERSHIP**

NAMI-FL’s membership in 2008 consists of **85** members – including both individuals and families. Membership dues are \$25/ for individuals and \$35/families.

### **4) PLANS FOR SUPPORT, EDUCATION, AND ADVOCACY FOR 2009**

#### **SUPPORT:**

NAMI-FL will continue to host its regular, monthly Support Group on the first Tuesday of each month....contact Jean Walters with questions at 273-4263. We will also offer individual and crisis support – in person or on the telephone. This will include support for families involved with the Behavioral Health Unit at the Cayuga Medical Center. Dr. Dean and Nicelee Hollenback both have our contact information if they need us. Contact Carol Booth with questions – 272-6573

#### **EDUCATION:**

NAMI-FL will sponsor its 8<sup>th</sup> Family to Family Education Course, taught by Ann Carter and Carol Booth. This Class will begin on Thursday, March 5, 2009 and run consecutively for 12 Thursdays through May 21, 2009 at the TC Action Building at 701 Spencer Rd. Carol will continue, along with support from BOCES/SETRC to present “Breaking the Silence” to District children and teachers as requested. She will be focusing on distributing more actual Lesson Plans for teachers to carry out this Program on their own. We will continue to keep our Library up-



to-date and to replenish our Brochures both from NAMI-NYS and NAMI National; we will publish our Winter Newsletter in the next month and another in late July/August – questions, comments, articles are always welcome – contact Deb Grantham at 277-5148. We will continue to supply the hospital unit with family packets – as requested. In May, Carol Booth will help to host a Tompkins County Mental Health Services Recognition Event in the downtown area – as part of her role on the TC Mental Health Services Board. She is hoping to encourage focus on NAMI-FL at this time and help community members to understand all that we offer – Support, Education, and Advocacy regarding mental illnesses. We will celebrate Mental Illness Awareness month in October by an educational/fundraising and awareness event, still to be determined.

Hopefully, more NAMI-FL members and friends will think about attending the Educational Conference to be held on October 9, 10, and 11, 2009 at the Desmond Hotel in Albany, NY.

#### **ADVOCACY:**

We hope that our members and friends will continue to write Guest Columns and Letters to the Editor concerning topics relating to Mental Illnesses. Carol Booth will continue to serve as Vice-Chair of the County Mental Health Services Board and Chair of the MR/DD Subcommittee – always attempting to serve the interests of our Families and Loved Ones. She will also continue to serve as Secretary of NAMI-NYS for one more year.

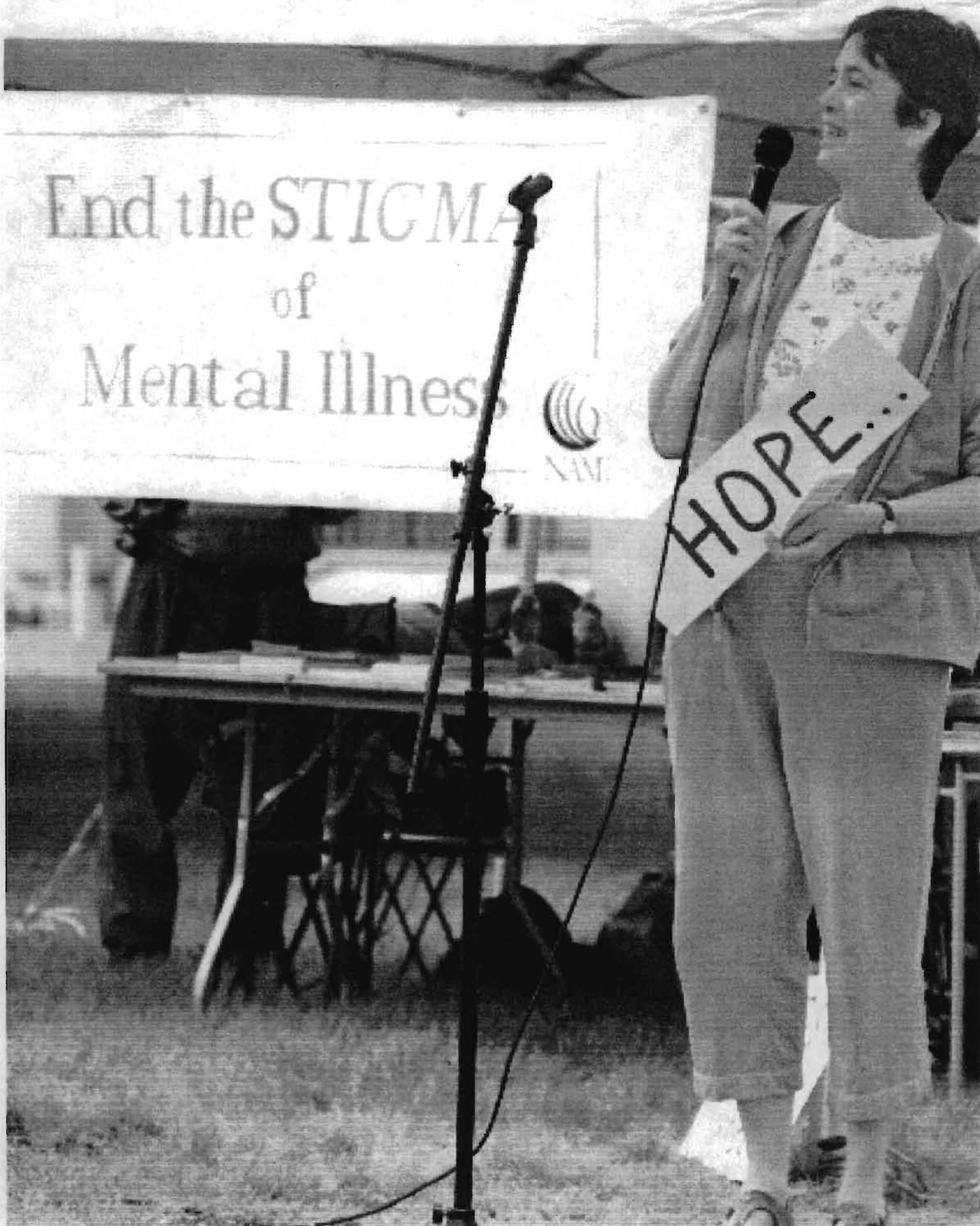
